Terms and Conditions of trade

By accepting our merchandise you accept our trading terms and conditions.

Pricing

1. Prices are based on current ruling costs including administration, labor, materials, freight, insurance, foreign exchange, customs duty, and landing charges, and on the latest quotations from suppliers.
- 2.. Prices are subject to alteration by K-Cosmetics Limited without notice and should be those prices prevalent at the time of dispatch unless K-Cosmetics Ltd has agreed in writing with Buyer to supply goods at a fixed price.

Payment

3. Payment in full shall be made to the K-Cosmetics Limited on or before the 20th day of the month following the date of the invoice.
4. Without prejudice to its rights under these conditions or at law or in equity if payment is not made on the due date K-Cosmetics Limited may charge interest on the overdue amount at the rate of 2.5% per month or part month from the due date for payment until actual payment is received.
5. K-Cosmetics Ltd also reserves the right to restrict or withhold the supply of further goods on credit.
6. The Buyer agrees that K-Cosmetics Limited shall be entitled to recover all or any expenses, disbursements and legal costs incurred by the Seller in enforcement or attempted enforcement of its rights contained in this Agreement including any reasonable Solicitor's fees or debt collection agency fees.

Delivery

7. Courier Freight Fees apply. Backorders are sent freight free.
8. Goods damaged via delivery or not received must be claimed immediately, against the carrier. Upon arrival, please ensure goods are checked for damage and tally with Packing Slip or invoice. If you are unable to do this, write Subject to Checking when signing the receipt.

Credits and returns:

9. All sales are final.
10. Defective goods will be replaced or credited and must be returned for evaluation and credit within 7 days from invoice date. In all cases please quote invoice number.
11. Authorization must be obtained prior to return of stock from K-Cosmetics Ltd. If customer returns the product, the name, address and phone number of the customer must be forwarded together with the product.
12. Opened or used goods cannot be credited.
13. Goods purchased by the Buyer are non-returnable, unless it is agreed in writing within seven (7) days following receipt of goods by the Buyer in which case a re-stocking fee of up to 40% of the value of the goods supplied may apply.

Retention of title:

14. All goods sold and delivered to the purchaser shall remain the property of the vender until the purchaser has paid the full price.
15. In the case of default in payment by the purchaser the vendor shall have the right to retake possession of and permanently retain such goods.
16. The vendor may require the purchaser to store the goods in such a way as to identify such goods as the property of the vender. The purchaser shall not pledge or assign by way of security any of the goods before payment may not have arrived the vender may have the right to retake possession of the goods.
